We have a Sunlight Sauna here at Slender Lady of Teays Valley. We got it back on March 28, 2005 and we love it. Our customers love it also.

We let our members use the SS unlimited monthly by appointment only for \$40.00 a month. A non-member uses it for \$15.00 a 30 minute session or \$50.00 unlimited monthly. There are many days that the Sunlight Sauna is on all day. We open at 7AM and close at 8PM. We schedule 45 minutes apart to give the customer time to undress, sit in the SS for 30 minutes and get dried off and dressed again. There are 17 appointments available each day and there are many days that there are no available appointments. Our customers have started scheduling 30 or more days in advance to use the SS. The SS pays for itself in less than 6 months. There is very little work involved with the SS, except for washing and drying towels. We made the mistake of providing the towels. Very soon we are going to change and put up a sign to bring your own towels. The towels have been the only down side to the SS.

Our customers are being asked by their physicians to use our SS. My doctor also is the reason that we made the purchase. I would recommend that all SL locations get a SS to bring in easy money and then make all the physicians in your area aware of your SS. The Airbrush tanning is a lot messier and takes your employees time where the SS only requires you set the timer and wipe it out every now and then with water and clean the windows. So, the room we were using for Airbrush Tanning is now our Sunlight Sauna.

It has been the best thing for my health that I have ever invested in. The SS helps with joint and muscle pain, swelling, skin conditions and has lowered my blood pressure to the point that I do not need medications. I am a diabetic and I have Lyme disease also, and the SS has been a life saver for me. I own the franchise with my daughter-in-law and the only time we can use the SS is before work and after work because we do not have appointments. We may very well get a second SS in the near future if the appointments continue. We have several members with Fibromyalgia and other chronic pain illnesses that would not miss a day in the SS.

The Sunlight Sauna does the very same thing that a Body Wrap does but much more than just detoxification and weight reduction. We have quit doing the Body Wraps which are very time consuming and encourage our Body Wrap customers to use the Sunlight Sauna.
